Board of Deferred Compensation

Discussion:

Below are the Deferred Compensation Plan (DCP) project and activity updates for December 2022:

A. Legislative Update

 SECURE 2.0 Act – In March of 2022, the House of Representatives passed the Securing a Strong Retirement Act (SECURE 2.0 Act). At the time, Segal and Mercer both reported the possibility of SECURE Act 2.0 passing through the U.S. Senate as well. Staff learned that on December 23, 2022, the U.S. Senate passed the Consolidated Appropriations Act, 2023, which contains the SECURE 2.0 Act. The bill was signed into law by President Biden on December 29, 2022. A summary of the SECURE 2.0 Act and its impact on governmental 457 plans will be provided to the Board at a subsequent meeting.

B. Operations and Project Updates

- 2023 DCP Board Election for Active LACERS Representative and Active LAFPP <u>Representative</u> – The terms for both the Active LACERS Representative and the Active LAFPP Representative expire June 30, 2023. Staff is coordinating with The Office of the City Clerk - Election Division (City Clerk) to administer the election and to establish timelines and disseminate communications. A report will be provided to the Board during the next meeting with key election dates and calendar, and policies and procedures for candidate nomination. The election will be held in May 2023 in accordance with the DCP Election Policies and Procedures.
- Schwab Self-Directed Brokerage Accounts Minimum Balance: Final Update Staff directed Voya on November 30, 2022 to initiate fund transfers by selling of shares for the remaining 65 participants in order that the core minimum balance requirement of \$2,500

could be fulfilled. Staff was informed that Schwab completed the process on Friday, December 9, 2022 with the funds settling and being transferred from Schwab SDBA to the core investments on the same day. Due to market fluctuations, eight (8) accounts had dropped in value, which required additional shares to be sold. As of December 20, 2022, all accounts were settled.

C. Communications Updates


- <u>2023 Participant Outcome Goals and Strategies</u> The Board approved of staff's recommendation for 2023 participant outcome goals and strategies on September 29, 2022. Staff has begun launching communications campaigns in line with the approved strategies, beginning with an enrollment campaign in January.
- Money Matters Zoom Virtual Meetings In October 2020, staff launched "Money Matters" virtual meetings for employees to interact with DCP local retirement counselors via Zoom. During these sessions, DCP local retirement counselors provide education on various topics and answer participant questions. General DCP information virtual meetings are held on the third Wednesday of every month from 12:00 p.m. to 1:00 p.m. Attendance for December virtual meeting is provided in the following table:
